Message from the Chief Executive

Another year has passed for the Halberg Foundation, and just like any organisation we have had our highs and our lows.

A personal moment of joy for me, was stepping into the role of Chief Executive in October 2022. However, this joy was soon met with the somber news of the passing of our esteemed founder, Sir Murray Halberg, in November. The widespread acknowledgment that followed was everything that Sir Murray deserved.

Sir Murray Halberg's legacy extends beyond his Olympic gold medal: for me hearing more about his dedication as a husband, father, and advocate for disability, sport and recreation was what I enjoyed most. It was in these facets of his life that his true greatness emerged. Together with my dedicated colleagues at the Foundation, we are committed to ensuring that his legacy lives on through our work.

The 60th ISPS Handa Halberg Awards provided a platform to pay our respects to Sir Murray, celebrating his life and achievements. The Awards was yet another fantastic evening of entertainment celebrating the nation's amazing sporting achievements. The night belonged to Snow Sports, with snowboarder Zoi Sadowski-Synnott and skier Nico Porteous winning the Sportswomen and Sportsman of the Year titles. Their Snow Sport colleagues Gustav Legnavsky and Corey Peters claimed the Emerging Talent prize and Para Athlete/ Para Team of the Year.

Over the year, we continued to deliver life-changing services

and events across the country like the Halberg Games - where many young people with disabilities experience freedom and independence for the first time. They also participate in a lot of sport and recreational activities where the real joy and humanity can be witnessed at the finish line.

Our collaboration with the Eagles Golfing Society has allowed us to provide funding for equipment that enables individuals and families to partake in activities that enhance their quality of life. Whether it is a family bike ride or independent swimming lessons, these opportunities create lasting memories.

Our network of Advisers continues to play a pivotal role in educating schools, clubs, and national sports partners on creating environments that are accessible and open to all. Inclusion Training, the Jewel in the Crown of Halberg's offerings, is evolving. While Advisers will still deliver the training in person, we are excited that a digitalised version will be available via various platforms next year. Short training videos on our website will cover the theoretical aspects, allowing users to access content at their convenience. Advisers will then focus on delivering the practical elements, the part we know they find most engaging. This project has been made possible by the support of Sport New Zealand Ihi Aotearoa and their Strengthen and Adapt initiative.

As part of the Strengthen and Adapt project, in the coming year, you will notice a fresh look for the Halberg Foundation.



While our name remains unchanged, we will have built a set of clear brand guidelines and a digitally-savvy logo that resonates with the times and connects with our core audience. young people with disabilities.

Throughout all our endeavours, young disabled individuals remain at the heart of our work. As our Youth Council would sav: 'nothing about us without us.' The Youth Council continue to be integral to the Foundation. both advocating for their peers and providing the key insights that the team and I need to take our work forwards.

It is an exciting time as we grow and help more families across Aotearoa.

Thank you to all our partners, sponsors and funders for your support, there are some exciting times coming for the Halberg Foundation. I would also like to thank our amazing network of Trustees who continue to fundraise across their regions.

On behalf of the Halberg board, we are pleased to present this year's Annual Report for the year ended 30 June 2023 in Halberg's 60th year.

It's an exciting time for Halberg with a fresh approach from new Chief Executive, Tom Smith, and the team are working hard to bring the newly agreed strategy to life, being:

- Amplify with Digital to modernise our delivery channels.
- Strengthen Relationships within the sector to achieve more: and
- Educate how to Involve youth with disabilities by working with organisations at a national level.

During the financial year, much work and planning has gone into securing Sport NZ Strengthen and Adapt funding which will enable the projects associated with the Amplify with Digital aspect to come to fruition from 2024.

With the settling of a new strategy and structure, several new faces have joined the Halberg team and we extend our warmest welcome. We also acknowledge our valued team members who have left Halberg over the past year, and we know that many of the "moments of joy" and stories contained within this annual report are the result of their significant contribution to Halberg and the wider sport disability sector, we wish them well.

As outlined within this report, as well as delivering disability sport advisory services. regional events and inclusion training, much activity has occurred over the past year including; one national and three regional Halberg Games; a successful 60th ISPS Handa Halberg Awards; inclusion work with many national sporting organisations; and various advocacy activities in conjunction with the Halberg Youth Council. Through our Kia sponsorship, Halberg also took steps to reduce our carbon footprint with an electric car fleet for our Adviser team.

The past financial year has seen Halberg achieve a small surplus and the team are extremely grateful to our partners, sponsors and donors who have made a significant difference to Halberg's ability to deliver our core services. This annual report also contains Halberg's first Statement of Service Performance, which provides audited non-financial measures identifying what the team have achieved during the period.

Finally, it was with much sadness that we acknowledged the passing of Sir Murray last November and we joined in an outpouring of recognition of who he was and all that he has achieved. A letter from Skylah-Rose, a recent Halberg Activity Fund recipient, was read out at Sir Murray's funeral and it encapsulated everything Sir Murray and the Halberg team have worked for "I thought I would be stuck without a chance of going out and doing things like other kids can, and the Halberg Foundation made it happen...."



Again, we extend our deepest thanks to our hardworking and generous Trustees, sponsors, partners, donors, to our Patron Dame Cindy Kiro and to the Halberg team and volunteers. Your belief in Sir Murray's vision has made a tangible difference to many over the past year and has helped sustain Halberg's work into the future.

Mitchell Rhodes, Halberg Adviser for Canterbury, successfully concluded the inaugural year of the "All Abilities Cricket" Programme, developed in collaboration with Canterbury Cricket and Parafed Canterbury. This programme fosters inclusive cricket experiences, breaking down participation barriers by tailoring games and activities to individual needs.

To ensure effective programme delivery, all staff underwent Halberg Inclusion Training at the season's start, encompassing practical and theoretical elements focused on adapting and modifying cricket-related activities.



In its first year, the All Abilities Cricket programme achieved the following goals:

- Enhanced skill development through modified activities.
- Increased enjoyment.
- A sense of accomplishment for all participants.
- Greater involvement of disabled youth in cricket within the region.











VULCAN.

The Halberg Youth Council are a group of young leaders who play an important role in supporting and advocating for physically disabled young people to have quality experiences in sport and recreation. The council had a very productive year, kicking off with a hui in July, hosted at Shore Junction, a youth innovation hub in Auckland.

Jaden Movold and Brooke Anderson seized a remarkable opportunity supported by the Office of the Children's Commissioner, where they joined their peers from New Zealand and presented before the United Nations. Sharing their personal narratives, Jaden and Brooke acknowledged the need for continued efforts to embrace and safeguard the rights of children.

The February hui for the Youth Council, was held alongside the ISPS Handa Halberg Awards. Sally Wenley, led an engaging and confidenceboosting media session for the council that was immediately put into action as some of the team took control of the Halberg Foundation's Social Media during the evening - interviewing sports stars like Dame Lisa Carrington, Ruby Tui and also Sir John Key.

During both the Halberg Regional Games in October and the National Halberg Games in April, the Youth Council undertook key roles, providing unwavering support to their respective regional teams. Additionally, their pivotal contributions extended to overseeing ceremonial aspects, orchestrating a quiz evening, and sharing their experiential insights during the whānau morning tea.

The Youth Council facilitated the recruitment of fresh members for the first time. This involved the creation of advertising graphics that were shared across the Foundation's social media platforms. Prospective candidates submitted comprehensive CVs and Cover Letters, that were reviewed by the Youth Council. Shortlisted individuals were then invited to interview, led by Brooke. The ultimate decisions were selected thorough deliberations between the Council, Halberg Adviser Mitch Rhodes and Alumni Anton Besseling.

To wrap up the year, Brooke Anderson, Dylan Lloyd and Guy Harrison attended the ISAPA Conference in Dunedin. Moderated by Alumni Kiran Dixon, the three joined in a panel presentation, where they delved into their personal experiences as young people with disabilities, navigating the realms of sport and recreation. The takeaways shared by the trio resonated with a diverse audience composed of international academics, catalysts of change, and sports facilitators.

Pasifika Leadership 2023

Building upon the success of the Waikato Manaakitanga Programme, the Halberg Foundation organised the 2023 Pasifika Leadership workshop in Counties Manukau.

This initiative was aimed to raise awareness for Halberg's sports and recreational activities within the region. Thirteen secondary school student leaders from Manurewa High School and Macleans College actively participated in the programme.

Spanning across two days, the programme featured a comprehensive itinerary.

It commenced with a training session led by the Auckland Halberg Adviser team followed up with a leadership seminar conducted by Simon Kent, President of Olympic Weightlifting NZ and the director of the Momentum Leadership Academy.

The 2023 Pasifika Leadership Programme was guided by Halberg Adviser Joseph Dan-Tyrell, and guest speakers including Tupou Neiufi and members from the Moana Pasifika Super Rugby team.



















QUALITY OPPORTUNITIES

Halberg Games 2022 and 2023

In 2022, the Halberg Foundation organised a series of Halberg Regional Games as an extension of the national Halberg Games, which had to be cancelled earlier in the year due to the repercussions of COVID-19.

Athletes proudly represented their respective regions during local two-day events that offered a diverse array of sports, ranging from beginner to competitive levels. These sports included athletics, swimming, golf, football, and archery.

The first event, 'Halberg Games South,' took place at Rangi Ruru Girls' School in Christchurch on 1-2 October. This event was open to athletes hailing from Tasman, Canterbury, South Canterbury, Otago, Southland, and the West Coast.

The 'Halberg Games North' festival occurred on 8-9 October at King's College in Auckland, welcoming athletes from Northland, Auckland, Waikato, Bay of Plenty, and Gisborne.

The final event featured athletes representing Taranaki, Manawatū, Whanganui, Hawke's Bay, and Wellington. These athletes were eligible to partake in the 'Halberg Games Central' hosted

on 14-15 October at Palmerston North Bovs' High School in Palmerston North. The cumulative attendance across these three events reached a remarkable record of 309.

Come April 2023, the National Halberg Games made a triumphant return. The event spanned from 14-16 April and was hosted at King's College in Auckland. Building upon the success of the Halberg Regional Games held six months prior, this three-day festival had its largest turnout yet.

Athletes aged between eight and 21 participated in various sports and activities as part of regional teams, totalling 20 diverse disciplines.



WRAPAROUND SUPPORT





The Halberg Activity Fund provides grants to physically disabled young people (5-21 years) to help overcome the financial barriers to participating in sport and recreation. These grants help pay for sports equipment, lessons and assistance at school camps. This year 290 grants were distributed around the country. 196 were given for lessons/ coaching, 73 went towards equipment and 22 helped young people attend school camps. The Activity Fund is supported by the Eagles Golfing Society of New Zealand.







The New Plymouth Girls High School student has a hearing impairment among others that impacts her balance and physical activity.

Eden will never be able to drive a car so is hoping to gain confidence on an E-bike, that will eventually become her main mode of transport. This will ensure she can become more independent in getting to and from the places she wants

MEET JASMINE JENNEY, CHRISTCHURCH

Nine-year-old Jasmine Jenney from Christchurch is hoping to build strength and gain confidence thanks to a Halberg Activity Fund for individual swimming lessons.

The Queenspark School student has Ataxia which can affect her movement, core body strength and focus - accessing any sport or activity has been hard.

"Jasmine loves being in the water" says teacher, Jessica O'Callaghan.

"It gives her the opportunity to feel light and she can move easily. She often shows me how she can 'walk by herself' in the water"

Jasmine said she's loved having swimming lessons.

"I like the feeling of being in the water because I can walk by myself and being able to do the same as my classmates".





MEET EMMA BROADLEY, DUNEDIN

Fourteen-year-old Emma applied for a Halberg Activity Fund for private hockey lessons, to help her gain confidence, make new friends and one day be part of a school team.

The Bayfield High School student has DCD which impacts on her ability to complete motor actions for participating in sport.

Emma recently expressed an interest in playing hockey, but required targeted and specialised skill practice to improve her confidence before joining a school team.

Over five lessons with Jolene Casey (Otago Hockey) Emma focused on individual ball control, dribbling, passing and receiving, hitting, goal scoring and tackling.

"She has shown some great improvement over the past 5 sessions," said Jolene.

"It has been fabulous to see her confidence grow, her willingness to openly share and converse with me and also to try new things".











The 60th ISPS Handa Halberg Awards were held on Wednesday 15 February 2023 at Spark Arena in Auckland, and broadcast live on Sky Sport and free-to-air on Prime TV.

The event was both a significant milestone of achievement and one of reflection and remembrance as the first Awards event since the passing of Sir Murray Halberg. Sir Murray re-established the Awards in 1963 to honour and celebrate sporting excellence, and as a major fundraiser for the Halberg Foundation.

There were nine awards announced during the live ceremony to honour and celebrate New Zealand sporting excellence in 2022.

New Zealand snow-boarder Zoi Sadowski-Synnott was named Supreme Halberg Award winner, having also won the High Performance Sport New Zealand Sportswoman of the Year Award, for winning New Zealand's first ever Winter Olympics Gold Medal in the Slopestyle competition.



Notes to the Summary Financial Report

FOR THE YEAR ENDING 30 JUNE 2023

1. General information

Halberg Foundation ("the Foundation") is a registered charity under the Charities Act 2005 and is domiciled in Auckland, New Zealand. The Foundation is a public benefit entity for the purposes of financial reporting in accordance with the Financial Reporting Act (2013).

The Halberg Foundation was set up in 1963 by Sir Murray Halberg for the benefit of children with disabilities. The purpose of the Foundation is to pay or apply in New Zealand the income and the capital of the Foundation in such amounts, at such times, and subject to such terms and conditions, as the Executive Board may decide for the benefit, education, advancement in life, or personal support in any way whatsoever of children with disabilities (including, without limitation, to enhance the lives of physically disabled younger New Zealanders by enabling them to participate in sport and recreation).

The purpose of the Foundation is to enhance the lives of physically disabled New Zealanders by enabling them to participate in sport and recreation.

2. Basis of preparation

(a) Statement of compliance

The summary financial report has been extracted from the full financial report for the year ended 30 June 2023 which was authorised for issue by the Executive Board on 11 October 2023. The auditor issued an unmodified audit report on the full financial statements dated 11 October 2023.

The summary financial report has been prepared in accordance with FRS 43: Summary Financial Statements. The full financial statements comply with Public Benefit Entity Accounting Standards Reduced Disclosure Requirements ("PBE Standards RDR") as appropriate for Tier 2 not-for-profit entities, for which all reduced disclosure regime exemptions have been adopted.

The summary financial report cannot be expected to provide as complete an understanding as provided by the full financial report of the Foundation as it does not include all of the disclosures provided in the full financial report. The summary financial report has been reported at a total level. The full financial report can be obtained from www.halberg.co.nz.

The auditor has examined the summary financial report for consistency with the audited full financial report and has issued an unmodified audit report on the summary financial report.

The Foundation is required by it's Trust Deed and the Charities Act 2005 to prepare general purpose financial statements.

This financial report was authorised for issue by the Executive Board on 11 October 2023.

(b) Measurement basis

The financial report has been prepared on a historical cost basis and is presented in New Zealand dollars.

(c) Use of judgements and estimates

The preparation of the financial report requires management to make judgements, estimates and assumptions that affect the application of accounting policies and the reported amounts of assets, liabilities, income and expenses. Actual results may differ from those estimates.

Estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimates are revised and in any future periods affected.

Judgements made in applying accounting policies that have had the most significant effects on the amounts recognised in the financial report include the following:

- Revenue recognition non-exchange revenue (conditions vs. restrictions)
- Whether there is control over an investee
- · Whether the Foundation is acting as an agent of Sport NZ for lead agency funding received
- Whether the investment in Halberg Endowment Fund is impaired

(d) Functional and presentation currency

The financial report is presented in New Zealand dollars (\$), which is the entity's functional currency. All financial information presented in New Zealand dollars has been rounded to the nearest dollar.

(e) Prior year comparatives

Where necessary certain prior period comparatives have been reclassified to conform with current year presentation.

Sport New Zealand has confirmed that Halberg Foundation as the lead agency is effectively holding these funds in trust for distribution to third parties rather than on the Halberg Foundation's own account. On the 1st of March 2022, Halberg Foundation transferred \$1,180,000 to Halberg Endowment Fund to fund certain organisational activities, initiatives and projects. This loan is not repayable for three years following the date of advance and following this repayment up to maximum of \$250,000 per annum can be demanded by the Foundation. Interest is accrued annually in arrears on the outstanding loan balance on 30 June each year which is calculated as 1% per annum less the annual return (net of investment fees). The annual return for FY23 was 4.35%, therefore the Foundation has recorded an interest revenue of \$63,130 (5.35% of the loan at balance date).

Statement of Compliance

This Statement of Service Performance is prepared for the year ended 30 June 2023. This statement was authorised by the Executive Board on the 9th of October 2023.

The Statement of Service Performance has been prepared in accordance with Tier 2 PBE financial reporting standards, which have been applied consistently throughout the period, and complies with New Zealand generally accepted accounting practice (NZ GAAP).

Who we are, what we do and why we exist?

The Halberg Foundation is a charitable organisation founded in 1963 by Olympic legend, Sir Murray Halberg ONZ. MBE on the belief that all people, regardless of their ability, should have equal opportunity to enhance their lives through sport and recreation. Since 1963, the Foundation has worked tirelessly to make Sir Murray's vision a reality for New Zealand's physically disabled people.

The core work of Halberg includes a team of regional Advisers throughout New Zealand. These dedicated and expert staff work with physically disabled young people and their families to get them involved in sports and recreation. They also collaborate with schools, local sport and recreation organisations, facilities and clubs to raise awareness and capability for the provision of inclusive sports programmes and events.

Halberg delivers Halberg Inclusion Training - an inclusive training course on adapting physical activity to include all New Zealanders in mainstream activities, events and programmes.

The Halberg Foundation also hosts the Halberg Games a national, three-day sports competition for physically disabled and vision impaired young people aged 8 - 21 years. The Games give the attendees the opportunity to compete against other young people with similar impairments and pursue further sports goals.

The Halberg Activity Fund provides grants to physically disabled young people (under 21 years) to help overcome the financial barriers that prevent them from participating in sport and recreation. These grants help pay for sports equipment, lessons and assistance at school camps.

Halberg's flagship fundraising event is the ISPS Handa Halberg Awards, New Zealand's pre-eminent sports awards to honour and celebrate sporting excellence.

Our vision is for all young people with physical disabilities to have an equal opportunity to participate in sport & recreation.

Our purpose is bringing about moments of joy.

We are all in this waka together, for all the people of New Zealand.

"He waka eke noa, mō Aotearoa whānui"

In developing the statement of service performance information for the period ended 30 June 2023 Management have made key judgements regarding the information to be presented.

The key judgements include:

- · An evaluation of what information is most appropriate and meaningful to users and stakeholders when assessing performance against our purpose and objectives.
- Providing an appropriate balance between providing comprehensive information on the Foundation's service performance ensuring the report is concise and focused.
- · Consistent presentation and disclosure of performance information, to facilitate meaningful comparisons overtime, allowing users to evaluate changes and trends in service performance effectively.

To enhance transparency, disclosure of relevant assumptions, estimates and limitations have been included within this report.

Objective 1 - Inclusion Education

We deliver inclusion education to Schools, Clubs, Regional Sport Trusts, and National Sport Organisations to name a few. This is delivered in a mix of formats and styles tailored to the organisation's requirements.

The aim of the course is to increase knowledge and skills of teachers and sport deliverers to give them the confidence and resources to deliver quality sporting opportunities to all.

We utilise digital systems and technologies to distribute inclusion training resources nationally, as well as improving the end user experience using the organisation website and online application/registration/forms and portals.

Objective 3 - Youth

We recognise that connection with all our young people and their whanau is critical to our work, ensuring that they are at the centre. A key part of this connection is our Youth Council, who can provide insight and ideas to drive programmes and work forward.

As our primary cohort is aged between 5 and 21, it is imperative that we continue to invest in and find new young people and families to support.

In addition to growing our cohort, we are an organisation who needs to understand what our cohort need and want from their physical activity. We outwork this through facilitating a Youth Council, 10 disabled young people from around New Zealand who help to direct and define aspects of the work we do. Currently, young people are only eligible between the ages of 17 - 21.
