

HALBERG – CoachMate download competition.

1. **Promoter:** The promoter is Halberg, whose registered office is at Axis Building, Unit 2.5, 1 Cleveland Road, Parnell, Auckland 1052.
2. **Eligibility:** The competition is open to residents of New Zealand, except employees of Halberg and their immediate families.
3. **Entry Requirements:** There is no entry fee and no purchase necessary, other than downloading the CoachMate App and completing one of the courses on the Halberg tab.
4. **Agreement to Terms:** By entering the competition, entrants agree to be bound by these terms and conditions.
5. **Entries:** Only one entry per person will be accepted. Multiple entries from the same person will not be accepted.
6. **Closing Date:** The closing date for entries is **Friday, 13 December 2024**. No further entries will be accepted after this date.
7. **Entry Responsibility:** The promoter accepts no responsibility for entries not received for any reason.
8. **How to Enter:** To enter the competition:
 - Download the CoachMate App.
 - Register and add Halberg as your sport.
 - Complete at least one course on the app.
 - If you have previously downloaded the app, you can still enter by completing one of the courses.
9. **Amendments:** The promoter reserves the right to cancel or amend the competition and these terms and conditions without notice.
10. **Third-Party Information:** The promoter is not responsible for any inaccurate prize details supplied by a third party connected with the competition.
11. **The Prize:** The prize is up to **\$1,000 worth of sports equipment** from **Hart Sport** for a school, sports, or recreational organisation of the winner's choice.
 - The winner will choose the recipient organisation, which will need to provide an invoice/quote for up to \$1,000 worth of sports equipment from [Hart Sport](#).
 - The invoice should include the name of the benefiting school or organisation.
