You can vote for "New Zealand's Favourite Sporting Moment (the "Award") which will be presented on the night.

By submitting a vote for the Award, you indicate your acceptance of all of the following terms and conditions. The Promoter of this award is the Halberg Foundation.

If you do not agree to these terms, do not vote.

Voting for the Award begins at 4:30pm on 16/01/25.

Voting continues until 8.15pm on 18/02/25.

Votes are conducted online, and you may vote only once per day, 12.00am-11.59pm.

The finalists for New Zealand's Favourite Sporting Moment were determined by nominations from National Sports Organisations and a voting academy of sports media, independent of the Halberg Foundation.

- The Finalist who receives the highest number of public votes & over all engagement will be announced the winner at the 62nd Halberg Awards on February 18, 2025.
- In the event of an equal number of votes, all tied Finalists will be judged by an independent consultant, who will determine at its sole discretion which Finalist should win.
